#### **Empty Homes Premium**

If your property is unoccupied and unfurnished for 2 years or more, a 100% empty homes premium will be charged. This means the Council Tax will be charged at 200%. Visit **www.havering.gov.uk/counciltax** and see the Council Tax booklet for more information.
